Statement Of Intent

It is our intention to make our Playgroup and Preschool accessible to children and families from the whole of the village and local community.

Aim

We aim to ensure that our community has access to the Overton Preschool Playgroup through open, fair and clearly communicated procedures.

Policy

We endeavour to provide Early Years Education as widely as possible for our community.

Method

In order to achieve this aim, we operate the following admissions policy.

- We ensure that the existence of the preschool playgroup is widely advertised in places accessible to the whole of the community.
- We ensure that information about our preschool playgroup is accessible - in written and spoken form - and, where appropriate, in different languages. Where necessary, we will try to provide information in Braille, or through signing or an interpreter.
- We describe our preschool playgroup and its practices in terms of how it treats individuals, regardless of their gender, special educational needs, disabilities, background, religion, ethnicity or competence in spoken English.
- We describe our preschool playgroup and its practices in terms of how it enables children with disabilities to take part in the life of the preschool playgroup.
- We arrange our initial waiting list in the order that the application is received.
- We describe Overton Preschool Playgroup and its practices in terms which make it clear that it welcomes fathers and mothers, other relations and other carers, including childminders.
- We monitor the gender and ethnic background of children joining the group to ensure that no discrimination is taking place.
- We make our equal opportunities policy widely known.
- We take children from the age of 2 years.
- We keep a place vacant, to accommodate for an emergency admission.
- There is a one off voluntary contribution of £50.00 to secure your place. This contribution is to cover any additional costs for consumables and activities throughout the year.

Setting Capacities

Overton Community Centre

Monday – Friday

26 Places in the morning sessions; 26 Places in the afternoon sessions.

St Lukes Hall (Preschool children only)

Monday – Friday

24 Places in the morning sessions; 24 Places in the afternoon sessions.

Start time: 8.45am

Finish time: 3.15pm

Allocation Of Sessions

After your application has been received, you will be invited to notify us which sessions you would like for the next academic year at the start of the Summer term prior to starting. We cannot guarantee your preferred choices.

Children can only attend the St Lukes Hall setting in their preschool year group (we are not able to insure children under 3 at St Lukes Hall). Depending on the size of year group limited sessions may apply at the St Lukes Hall setting. Children can expect to have sessions at both the Community Centre and Primary School settings during their preschool year.

Sessions at the St Luke's Hall setting are allocated on a case-by-case basis dependent on the following criteria: children have attended Overton Playgroup, number of places at each setting, the child's personal requirements.

Childcare Support

From April 2024, 2-year-olds can claim 15 hours free childcare per week the term after their 2nd birthday subject to entitlement (to qualify both parents must be working and each parent must each expect to earn on average, at least £167 per week (equal to 16 hours at the National Minimum or Living Wage).

All 3- to 4-year-olds can claim 15 hours of free childcare per week from the start of the term following their 3rd birthday depending on availability of spaces.

Hours taken over 15 hours (or 30 hours for those entitled) will be charged at our hourly rate of £6.50

Government has announced the following schemes coming soon:

- From Sept 2025 – Up to 30 hours for eligible working families in England with a child from 9 months old up to school age

Notice: If a child is to be withdrawn from the Overton Preschool Playgroup or reduce their hours, half a term's notice must be given in writing or the parent/carers will be liable for the half term's full fees in lieu of notice.
